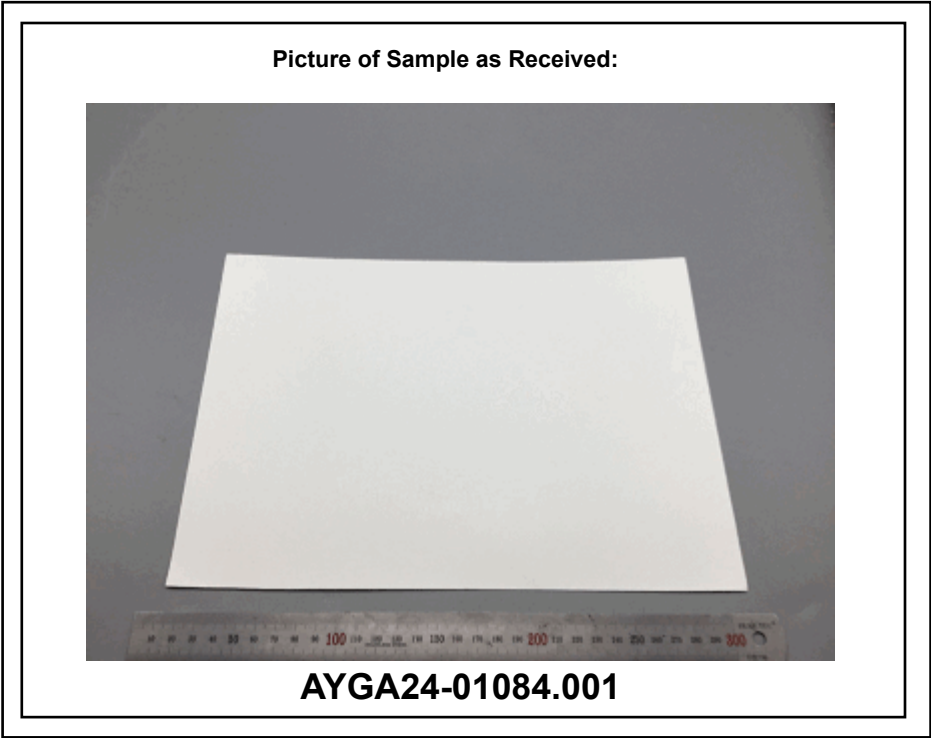

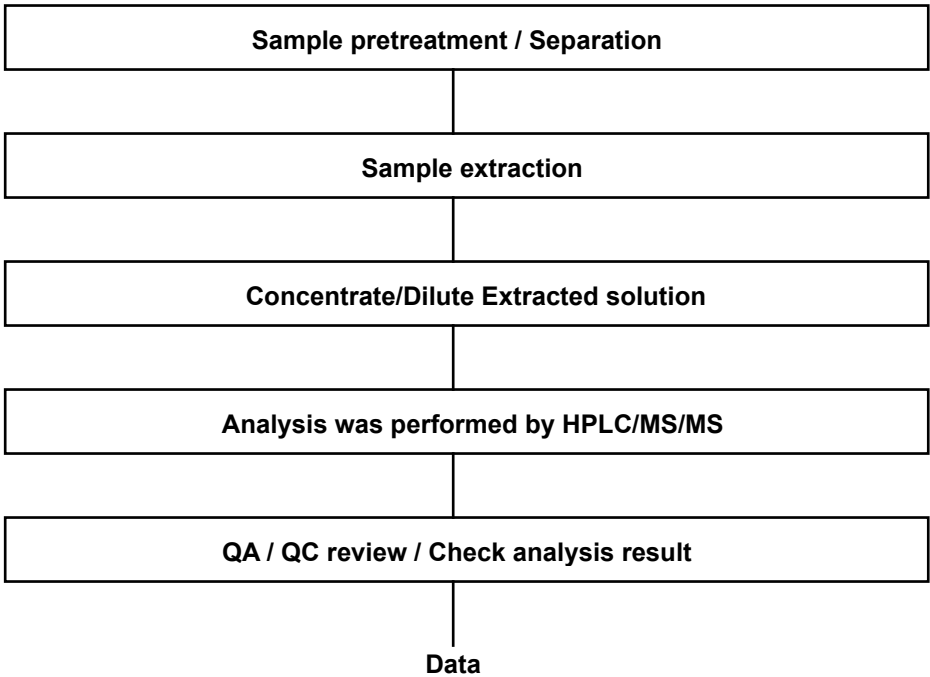

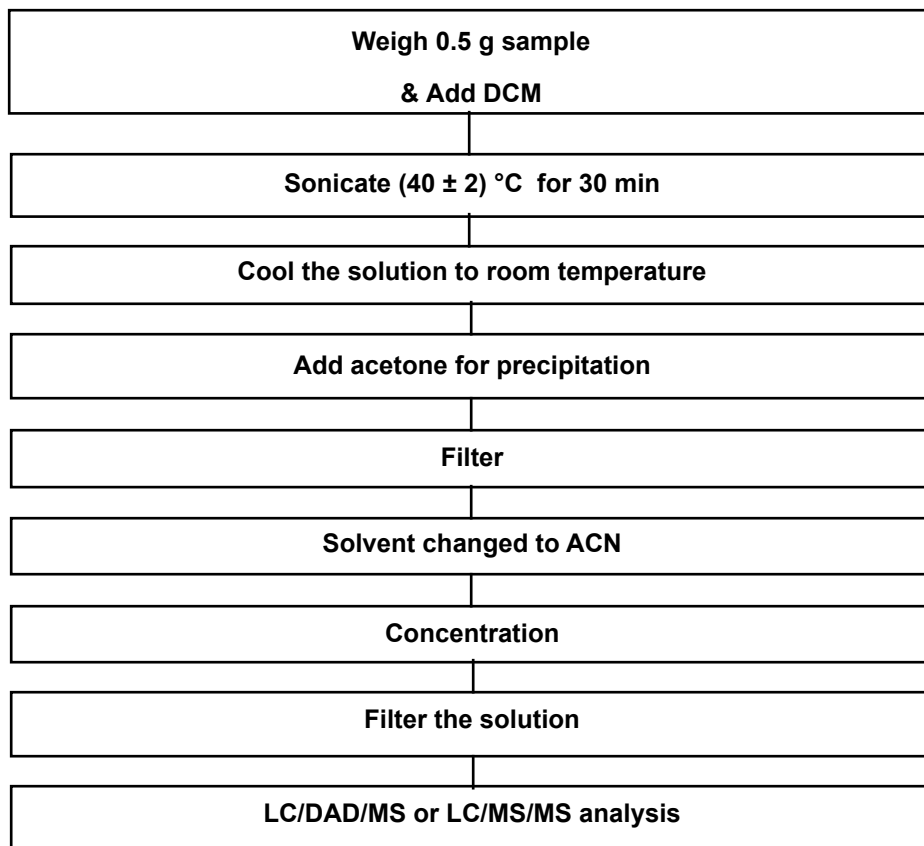
Flow Chart for PFOS/PFOA Test
